DON’T: “LIT Suite” or “Lit Suite” or “LitSuite” etc.

All app names are displayed in “**PascalCase**” where
the first letter of each word is capitalized: **TrialPad**,
TranscriptPad, **DocReviewPad**, **TimelinePad**, and
ExhibitsPad.

DON’T: “Trialpad”, “Trial Pad”, Trial pad”, etc.

The **LIT SUITE** gives you the tools
to review documents, summarize
transcripts, organize events, and
present evidence.

TrialPad

Review, organize, issue code, and bates stamp documents; then create production sets with detailed reports.

TimelinePad

Link people, issues, facts, and events to evidence; then present interactive timelines.
